A RESOLUTION ESTABLISHING FEES FOR THE COLLECTION AND DISPOSAL OF RESIDENTIAL AND COMMERCIAL SOLID WASTE, BULK WASTE, TEMPORARY DUMPSTERS, AND BRUSH/LIMBS

WHEREAS, Section 78-91 (a) and (b) of the Code of Ordinances of the City of Pinehurst provides that all residential and commercial solid waste, bulk waste, temporary dumpsters, and brush/limbs waste collection and disposal fees in the City shall be established from time to time by the City Council by Resolution and included in Appendix B to the Code of Ordinances, and;

WHEREAS, the City has elected to contract with Piney Woods Sanitation, Inc. for the contract year October 1, 2022 through September 30, 2023, and;

WHEREAS, Piney Woods Sanitation, Inc. has requested and been approved for a six percent (6%) increase for fiscal year 2022-2023, and;

WHEREAS, the City Council has determined that it is necessary to adopt fees adequate to cover the cost associated with the collection and disposal of residential and commercial solid waste, bulk waste, temporary dumpsters, and brush/limbs;

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Pinehurst, Texas, that:

The following fees for the collection and disposal of residential and commercial solid waste, bulk waste, temporary dumpsters, and brush/limbs are hereby adopted and authorized with an effective date of the first billing cycle occurring on or after October 1, 2022:

Bulk Pickup:

Extra bulk waste not picked up by the City's contracted sanitation provider will be

picked up by the City for a fee of \$25.00 per bulk item.

Bulky Waste includes: Stoves, refrigerators (with all CFC removed), water tanks,

washing machines, furniture and other similar items, and materials with weights

or volumes greater than those allowed for containers.

Construction Debris, Dead Animals, and Hazardous Waste is not considered to

be bulk waste and the disposal of such items will be the responsibility of the

<u>resident.</u>

BE IT FURTHER RESOLVED, that the fees established herein be

included in Appendix B of the Code of Ordinances of the City of Pinehurst for

reference.
